## Staying Conditions for Dog Friendly Rooms

1. You may stay with your dog(s) only. You may NOT stay with other animals.
2. Accompanying dogs must be litter-trained and must be sufficiently trained not to cause disturbance to other guests, including, but not limited to, by unnecessary barking or snatching.
3. Accompanying dogs per room must be limited to 2 small or medium dogs or 01 large dog.
4. Accompanying dogs must have received a rabies and virally-transmitted disease inoculation (compound vaccination for 5 or more types) 2 or more weeks prior to arrival and within 1 year prior to arrival.
5. You must submit a copy of a medical certificate to certify the inoculation described above at the time of booking.
6. Accompanying dogs must be at least 4 months old.
7. Accompanying dogs must be disinfected for parasites, including, but not limited to fleas and ticks prior to your visit.
8. Accompanying dogs must NOT be in their estrus period (within 4 weeks from the commencement of menstruation) or pregnant.

Additionally, please be aware in advance that we reserve the right to refuse accommodation to any dog which poses a significant risk to disturb other dogs.

## Notes for Using Dog-Friendly Rooms

1. Please do NOT bathe or shampoo your dog in a guest room tub. You may use shower area only.
2. Please do NOT let your dog sit or sleep on human furniture.
3. Please wipe your dog's feet after returning from outside area.
4. Please let our reception desk know your convenient time for our housekeeping services. We cannot offer our housekeeping services while your dog is unattended in your room.
5. Please exercise all due caution to ensure that your dog does NOT cause any damages to our facilities, including, but not limited to, our hotel building and furniture. Any damages caused by your dog will be charged.
6. Please do NOT perform grooming, including, but not limited to trimming or brushing on the balcony or on the walking area. Please dispose of wastes, including, but not limited to combs made by trimming or brushing in your room and be sure to keep the windows closed.

7. In case of any waste excretion at any place other than your room toilet, please promptly dispose of the waste in a hygienic manner. In case of any waster excretion in a common area, please inform your nearest hotel staff.

8. When going outside with your dog, be cautious of vehicles around the hotel and be certain to use a leash to avoid disturbing other guests or neighbors. Please be responsibility for any dog excrement and dispose of it properly into a sanitary container at our garbage collection area.

9. Please refrain from letting your dog enter hotel facilities (including, but not limited to, hotel buildings, access ways, or chapels) other than your room and courses designated by the hotel.

Please understand in advance that we may refuse your stay at our hotel if you make any false statements on this form, if you or your dog breaches staying conditions or notes on this forms, or if you or your dog causes disturbances, dangers, or accidents to other guests.

Although we will make our best effort to welcome your accompanying dog to our hotel, we are not liable for any matters if your dog is injured, missed, or killed in an accident. Furthermore, we cannot be held responsible for any trouble between you, other staying guests and/or your dog.

Please be sure to send us a copy a medical certificate of inoculation.
